



OWNER'S LIFETIME NATIONAL LIMITED WARRANTY

Collision Solutions, Inc. provides an Owner's Lifetime National Limited Warranty on all completed repairs for as long as you own your automobile. Collision Solutions, Inc. will correct any faulty workmanship upon proper notification and approval. This Warranty is void if any person or repair facility other than Collision Solutions performs any work on your vehicle to correct the problem without express written approval from Collision Solutions, Inc. Any attempt to repair, releases Collision Solutions, Inc. from any liability to repair under this warranty.

Collision Solutions, Inc. hereby provides an Owner's Lifetime National Limited Warranty on metalwork, painting, mechanical repairs, and parts furnished by Collision Solutions, Inc. This Lifetime National Limited Warranty is valid only for as long as the covered motor vehicle is owned by the person to whom this Lifetime Limited National Warranty is granted. That person's name appears on this document and on the original work order. This is a LABOR ONLY, fragmented, four part Lifetime National Limited Warranty and restrictions and stipulations pertaining to each fragmented part are stated as follows:

METALWORK: Collision Solutions, Inc. provides this Owner's Lifetime National Limited Warranty on all metalwork. This warranty includes welding and the application of materials utilized in making collision repairs against cracking, flaking, pitting or deterioration. Rust repairs are specifically excluded. Collision Solutions, Inc. will repair and repaint any metalwork warranted hereby at Collision Solutions, Inc. sole option. When a claim is made within the warranted period unless such damage was caused by, or resulted from, unreasonable use, maintenance, or care of the covered vehicle.

PAINTING, STRIPES, AND DECALS: Collision Solutions, Inc. provides this Owner's Lifetime National Limited Warranty from the effective date herein on painting related priming and painting work, against solvent blistering, peeling, hazing, and excessive loss of pigmentation. This warranty excludes those defects which are caused by any extreme environmental conditions to which the vehicle may be exposed. Collision Solutions, Inc. at its sole option, will re-prime, re-paint, re-stripe or re-decal the specific section or sections of the vehicle warranted excluding rust repairs when a claim is made within the warranted period, unless such damage was caused by or resulted from unreasonable use, maintenance, or care of the vehicle. This paint warranty is valid only over original factory finishes that are free of defects. This paint warranty does not cover chips, dings, or scratches that are a part of everyday wear of the vehicle.

MECHANICAL REPAIRS: Collision Solutions, Inc. provides a Lifetime National Limited Warranty on all mechanical repairs pertaining directly to the original collision damage excluding suspension, air conditioning or other electrical assemblies or components. Collision Solutions, Inc. will repair any mechanical assembly or component warranted hereby at its sole option when a claim is made within the warranted period unless such damage was caused by or resulted from unreasonable use, maintenance or care of vehicle.

PARTS: Collision Solutions, Inc. provides a Lifetime National Limited Warranty on new or used parts installed by our technicians. This warranty will not exceed the manufacturers warranty on the subject parts excluding suspension, air conditioning or other electrical assemblies or components. THIS WARRANTY DOES NOT EXCEED MANUFACTURERS WARRANTY. Collision Solutions, Inc. will repair or replace any defective part warranted hereby at its sole option when a claim is made within the warranted period unless such damage was caused by or resulted from unreasonable use, maintenance, and care of the vehicle.

THIS OWNER'S LIFETIME NATIONAL LIMITED WARRANTY shall be null and void if the repair is altered, adjusted or tampered with by any person or repair facility not authorized by Collision Solutions, Inc. This warranty is good as long as the person to whom this Lifetime National Limited Warranty remains the owner of the subject vehicle.

SPECIFICALLY EXCLUDED are incidental costs such as; towing fees, car rental charges, travel expenses, or assemblies and components which are not specifically covered by this Lifetime National Limited Warranty. Consequential damages such as damage to other assemblies and components resulting from a defective part or installation of such part installed or repaired during repair are not covered.

THE TOTAL EXTENT OF THIS OWNER'S LIFETIME NATIONAL LIMITED WARRANTY SHALL NOT EXCEED THE TOTAL COST OF THE ORIGINAL REPAIR.

THIS CERTIFICATE STATES ALL OF THE OWNER'S LIFETIME NATIONAL LIMITED WARRANTIES MADE BY COLLISION SOLUTIONS, INC. AND CONTAINS ONLY THE PROMISED FOR WHICH IT WILL BY HELD RESPONSIBLE. THERE ARE NO IMPLIED WARRANTIES.
